**Optional Candidate Comment:** It is shameful that these monies have been swept for other purposes over the years. Especially when so many people are still suffering from a loss of housing after Hurricane Irma. The housing trust fund should be used for housing.

**DEATH PENALTY REPEAL:** Ending Florida's use of the death penalty while preserving the alternative of a life sentence without parole?
